Statement of the research problem(s)

Gandhi was a journalist, but he was not a professional reporter working for a commercial newspaper. Rather, he published his own newspapers, and they promoted his various political, social, religious, and philosophical causes. The following study will look at his development as an advocacy journalist and assess just how successful he was in promoting his causes using his newspapers. Advocacy journalism means reporting and writing in a non-objective style while promoting an idea, innovation, or a particular point of view of an issue. This does not mean that is not fact based; rather, it is fact based and is not intended to be governmental propaganda. It often personal and tied directly to an individual. The tradition of advocacy journalism is a long one. Advoacy journalists have promoted republicanism, feminism, equality, prohibition, abolition, public health policy, vegetarianism, etc. ... A famous example of advocacy journalism was when Edward R. Murrow took on U.S. Senator Joseph McCarthy over the latter's claims about communist infiltration of the U.S. government and military. Gandhi was an exemplar of such journalism. He was a modern reolyutionary who worked for major changes in first South African and then Indian society. For example, he was a great proponent of equality, working first in South Africa and then India to make social equality universal and guaranteed by the political apparatus of each country. He had fought against discrimination in South Africa, and then Gandhi led the fight for the abolition of inequality as the foundation of an independent Indian society. Gandhi was also a journalist, for his entire political career. Indeed, journalism had a practical role in his life, as he, his wife, children, and various devotees worked each week throughout his adult life to put out a weekly newspaper. Gandhi used journalism as a political tool, a way to mold public opinion and to engineer social transformation. The Indian activist owned or edited six newspapers, one in South Africa and five in India. He also cultivated close relationships with journalists in both nations, as well as in other countries, as he developed his various political campaigns. Mass communication played a vital role in his rise as major national leader, and also helped expand his political legend after his assassination in 1947. The following study narrates Gandhi's career as an advocacy journalist—one who practices journalism for the purpose of advancing a political cause. Largely, advocacy is a form of a persuasive journalism. The study will examine his stances on equality and freedom through the written record, in his newspapers, and explains how he used those

newspapers to develop both his political causes and the public's image of the Mahatma. Indeed, Gandhi used his newspaper pieces as the content for his autobiography. The current study will show how he advanced human rights through his newspaper and pushed his political agenda on his readers. Gandhi generally made the campaign against untouchability as the center of his political philosophy, but he also wanted to unite Hindus and Muslims. The latter sometimes supplanted the former as his primary aim, placing the freedom and equality of India's lower castes in a secondary position. However, the relationship between Hindus and Muslims, the two largest portions of the Indian population, was integral to the kind of nation that Gandhi envisioned after independence would be gained. In fact, Gandhi was obsessed with getting Hindus and Muslims to live together in harmony. This would result in a united India. Thus, this proved to be a central theme of his advocacy journalism. Furthermore, his entire political philosophy—which had a strong religious underpinning—was built on the idea that all of mankind are brothers, and that the various communities must come together to build a great nation.

3. Goals of the research – anticipated outcomes including potential problem solutions, or contribution to knowledge or understanding of issues (maximum 400 words)

The goal of the research is to explain how Gandhi developed as an advocacy and to show how Gandhi used this kind of journalism to further his political, social, religious, and philosphical causes. This study will become a biography of Gandhi with the focus being his career as an advocacy journalist. The goal is to publish a book of nine chapters (approximately 300 pages) with a university press and to present the major findings at several mass communication research conferences, including the Association for Education in Journalism and Mass Communication, American Journalism Historians' Association, and the International Communication Association. The cost of the project will be Dh20,000. Most of those resources will be spent on obtaining microfilm copies of Gandhi's newspapers and traveling to the above nations to do primary research. The primary investigator will also pay one research assistant to help with the gathering of data.

4. Research methodology – anticipated methods to be used in your research process, including main research questions, data gathering, documentation or analysis planned (maximum 400 words)

The author will use a cultural historical approach, focusing on advocacy journalism as a powerful tool for political communication in a specific historical time period—in this case the late nineteenth and early twentieth century. The author will look at primary documents—that is, the newspapers themselves—and use a content analysis to determine certain advocacy journalistic patterns in Gandhi's writing. He will also examine the public record of Gandhi's work to see how the journalist himself saw his journalistic work.

5. Research schedule and deliverables – what are the major phases of your research anticipated, and what do you realistically plan to accomplish at what stage

Spring 2014: Gather data and write first chapter. Present that work to historians' conference in the fall of 2014. Continue with writing of second and third chapter in the fall of 2014. All of this is working toward a full manuscript that I expect to have completed by the end of 2015.
